As in years past, there will be hotdogs and sodas served between 12:00 and 1:00 pm. The meeting will begin promptly at 1:00 pm.

The **2021-22 proposed operating budget** is included for your consideration. Please bring the ballot along with you to the annual meeting or if you are unable to attend, send it to the office before June 5th.

In this budget, there is an increase of \$10 per month for dues and \$15 per month for water. This increase will begin July 1, 2021. The dues increase will primarily be allocated to the community's reserve fund. The water rate increase will be used to build the water reserves as well as partially fund replacement of the filtration system in the water plant. Engineering for this project is **underway**.

There are **3 Board of Trustee Positions** open. Frank Walls position expires on June 30, 2021. He has been serving for 12 years and will graciously continue for another 3 year term if elected. Mr. Simpson (20 years) and Ms. Goeth (2 years) have resigned their positions mid-term. Mr. Armitage was appointed to Mr. Simpson's position on April 14, 2021. If elected, he will serve for a 3 year term. We'd like to thank Mr. Simpson & Ms. Goeth for their many years of service and their contributions to the community. Nominations may also be made by **"Write-in" on the enclosed ballot or from the floor on June 5th**. If you have questions regarding board member responsibilities or if you are considering volunteering, please call one of the board members listed below for more information.
