WATER SYSTEM: We are pleased to announce that, as of February 2025, our water treatment facility is managed by **Oak Harbor Water Management, LLC.** For **After-Hours Water Emergencies** call **360-540-4442**. *Please use this number for emergencies only.*

- **Billing Clarification:** If you call Oak Harbor Water Management, for services related to your property's water line, and RHGC is billed for that service, the charges will be passed on to you, the customer.

The **COMMUNITY DOCK, BEACH AND PIER** are private membership amenities available for your enjoyment. To access them, you will need a keycard. If you don't have one yet, simply contact the office. Limit 1 per household. The float will return by Memorial Day weekend and will remain in place through Labor Day. This facility is for **day use only**, and there is no overnight moorage.

The **BASKETBALL COURT** and **BASEBALL FIELD** are available on a first come, first serve basis. For evening play, there's a push button light on the light post. The basketball court **closes at 10pm**, please be considerate and refrain from playing after this time.

Water Filtration System Update

We hope you've noticed improvement in the quality and taste or your water.

The new biological filtration system at Rolling Hills-Glencairn is now fully operational, enhancing water quality by pretreating with potassium permanganate and using naturally occurring bacteria to remove ammonia. This innovative process relies on nitrification, where beneficial bacteria convert ammonia into nitrate, reducing the need for chemical disinfectants like chlorine. Stable chlorine levels mean less reliance on chemical disinfectants, resulting in better-tasting and safer water overall. While the system is successfully running, we are continuing to fine-tune chemical adjustments to optimize performance and ensure the best possible water quality for our community.

In addition to this update, we have replaced all three bubbler system motors. These bubblers play a vital role in aerating the water in the large reservoir, enabling chlorine to off-gas effectively. Furthermore, the fan located at the top of the reservoir, which aids in exhausting off the gas, has been replaced as well.

It's important to note that the water filtration process that removes iron and manganese does not soften water. As Rolling Hills-Glencairn naturally has hard water, individuals may wish to install their own water softeners if desired.

On-Site Waste and Trash Storage

There have been recent complaints about improper solid waste storage and disposal in the community. To ensure a safe and sanitary environment, here are the guidelines for proper solid waste and trash handling.

Owners or occupants are responsible for keeping containerized solid waste stored safely. Containers must be durable, corrosion-resistant, and water-tight to prevent leaks and nuisances. Reusable containers should have tight-fitting covers, be rodent-proof, and, if manually handled, not exceed 32 gallons in capacity. Detachable containers must be designed to minimize odors and windblown litter. Additionally, putrescible (putrefiable) waste must be removed at least every 14 days or more frequently if necessary. Onsite storage in the back of an open trailer or on the ground is not acceptable.

Consequences & Reporting Violations

Failure to comply with these regulations may result in fines or enforcement actions by Island County and the Community. If you notice violators in your neighborhood, you can report them to Island County Public Health.
